Update-XIX NEW SLOTS, VACANT SLOT & ALLOCATION SCHEDULE FOR LEFTOVERS

1. 1st FELLOWSHIP:

A few more slots are available for session July 2022. Only leftover applicants are Eligible for these slots. All those who are interested in these slots are directed to come to PGMI office at **10am on 29th August 2022 (Monday)** for slot allocation. On arrival, please report to Mr. Sulaiman Khattak at Conference Hall near PGMI Library. Late arrivals will not be entertained.

SLOT ALLOCATION PROCESS: These slots will be allotted on merit amongst present eligible leftover applicants. If someone is unable to come in person, can appear through representative. The representative must bring authority letter and his own CNIC. There will be no option of surrender the slot once allotted.

Please see your **ELIGIBILITY STATUS** on your dashboard a day before interview. **The list of eligible applicants along with their merit is available on web site.**

Those who will get the slot allocated in PGMI affiliated hospital through interview, will not be eligible for NOC based induction. There will be no option for slot surrender for these applicants who get slot in this interview as per their choice and merit. They will not be eligible for any other slot allocation in this session and next session i.e. Jan 2023. If they opt not to join or resign at some later stage, will not be eligible for induction in next session i.e. Jan 2023.

Applicants who want to avail NOC based induction as per induction policy are directed to bring their original NOCs from the supervisor and head of the institution. If NOCs are produced more than the available slots from a single unit, preference will be given to the higher merit applicant. The NOC will be accepted till CPSP registration portal is closed.

ARRIVALREPORTS: The selected PG residents will be required to submit arrival report and do RTMC process till 31st August 2022. Detailed instruction will be given along with Placement order. The slot allocation will stands cancelled in respect of those who fail to submit arrival report and RTMC Step-II form in above given time.

Inductee of Jan 22 are not eligible for this induction as per induction policy and if they apply and pass the initial scrutiny undetected, they are still not eligible and whenever identified, will be terminated and disciplinary proceeding will be initiated against them. They are directed to exclude their names from the process of induction. Detailed scrutiny will continue and may take a few months.

1. **User Dashboard:** This will show you the status of your application-
 - **Formstatus:** Submitted or Pending on your part
 - **Marks Verification:** It shows your marks have been verified by the PGMI scrutiny committee. It will take a few days. When it shows Verified, please review your form for any correction made by PGMI scrutiny committee.
2. **Submission of Printed Form & Documents:** After online submission of application, this time, it is not required to submit Printed Form & Documents in PGMI office. Print the form along with uploaded documents, every page with number & user ID. It is required to submit this printed copy in PGMI office along with arrival Report if selected. Please take latest print from your dash board.
3. **PGMI Website & Facebook page:** Not to miss anything, it is advised to check PGMI website (www.pgmi.edu.pk) & Facebook page frequently for **Updates** till your induction process is complete.
