- 1. Seat allocation will be done through software, in case of any technical problem in software, interviews will be conducted telephonically or using conferencing software, or in person, depending upon the Govt. guidelines for meetings/gatherings.
- 2. NO applications shall be accepted after the above mentioned due date. <u>Incomplete forms in any respect</u> with wrong information will not be entertained. Deficiencies wrong information & mistakes in the form will not be corrected after submission.
- 3. Concealment of information /submission of fake documents or incorrect entry of information will lead to termination of training & reporting to CPSP/PMC/PMDC/debarring from future inductions in PGMI, Peshawar at any stage and will also be liable to refund stipend.
- 4. Scan Original documents for uploading (not from photocopies), otherwise application will be rejected.
- 5. Applications must be submitted online on <u>www.pgmi.edu.pk</u>. The only selected applicants shall submit the hard copies of application form & documents to the CEO's office PGMI, Phase IV, Hayatabad, Peshawar, at the time of submission of Arrival Report to PGMI Hayatabad Peshawar. These documents can be submitted personally or through courier service.
- 6. PGMI Diary number should be obtained at the time of personal delivery.
- 7. PGMI will not be responsible for the wrong entries/choices in online form filling.
- 8. NO TA/DA will be paid.
- 9. Foreign Nationals/candidates shall apply through their Govt. to Higher Education Commission, Islamabad. They are directed to apply in person after fulfilling of all the codal formalities.
- 10. Application process fee is Rs. 5000/= as non refundable/non transferrable. If applicant deposit fee more than once for one application none of it will be refunded. Fee should be deposited separately for each apply.
- 11. Admission fee of PKR 30,000/= to be deposited to PGMI at time of admission. Foreign Nationals will pay \$200 Dollars in addition to PGMI admission fee (Non refundable and submission is one time).
